<p>Yellow — Conditional</p>	<p>Higher risk, complex structure, non-standard operations. Requires enhanced review and controls.</p>
<p>Red — Decline</p>	<p>Sanctions/toxic exposure, missing documents, pressure to bypass compliance. We reject and explain why.</p>
